

## Scholarship Application

### Eligibility requirements to apply for a scholarship:

1. Scholarship applicant must be a full-time employee of a DLI member plant for at least 12 months prior to application.
2. The DLI member plant can receive ONLY ONE scholarship within a three-year period.
3. If a scholarship is awarded, the applicant must attend classes during the current year.
4. Anyone who manages the scholarship program or is related to anyone who manages the scholarship program is ineligible to receive a scholarship.

### Course you wish to apply for:

- Introduction to Drycleaning (5 day course)
- Advanced Drycleaning (10 day course)
- General Drycleaning (15 day course – combination of Introduction & Advanced courses)
- Cleaning & Stain Removal (5 day course)
- Wetcleaning (2 day course)
